**BOARD HIGHLIGHTS –MARCH 17, 2025 MEETING - 7:00 PM**

**CONSENT AGENDA** – The consent agenda was approved as presented, including selecting Giovanni Catalano as the next CCSD 89 Director of Buildings and Grounds.

**DISCUSSION ITEMS**

- **Vision 2030** Superintendent Eccarius shared Illinois Vision 2030 framework which provides a blueprint for keeping students and schools safe, attracting and retaining high-quality educators, enhancing post-secondary success, and more effectively measuring what is working well in schools in a timely, usable manner. Board Member Kemp expressed concern for adopting this resolution and the possible effect it will have on Board policies.
- **Registration/Enrollment/Staffing** (*Strategic Plan: High-quality staff; Academic success; and Effective use of resources*) Superintendent Eccarius discussed the importance of timeliness in registration, the challenges the District is currently facing as well as incentive ideas to encourage families to register early.

**ACTION ITEM** – The following items were approved:

- Resolution #897-25 Illinois Vision 2030 was tabled until the April 21, 2025 Regular Board Meeting.
- Approval of the GSF Contract Renewal for the 2025-26 School Year for a 2.9% Increase.
