**BOARD HIGHLIGHTS – APRIL 21, 2025 MEETING - 7:00PM**

**CONSENT AGENDA** – The consent agenda was approved as presented.

**DISCUSSION ITEMS**

- **Strategic Plan update** (*BOE Goals: Continuous improvement and improved student learning*). The board heard a general overview of the progress made toward strategic plan initiatives and next steps. Some of the updates were: the implementation of new curricular resources, a district-wide behavior committee that has been formed to advise on practices and procedures across the district and a new e-learning plan that has been implemented.
- **Employee Health and Dental Insurance Renewal** (*BOE Goal: Changing financial needs*). The Board reviewed employee health and dental insurance renewal options. The final renewal rates were a 6.9% increase for the PPO plan, a 4.2% increase on the HMO plan and a 4.0% increase for dental insurance.
