## **New Year Brings Schedule and Kindergarten Changes**

The beginning of the school year always brings a sense of renewal and excitement. This year, District 89 is proud to offer several changes aimed at better preparing students for learning success.

In grades kindergarten through fifth grade, the school day is 30 minutes longer this year. Elementary schools will use this time to enhance science, writing and social studies instruction and provide additional time for enrichment opportunities.

Full-day kindergarten is being offered to all 5-yearolds for the first time this year. The full day is providing more time to develop language and math skills as well as to expand time for social studies, science, art, music and physical education.

A new writing curriculum will focus on increasing student opportunities for creative, analytic and critical thinking skills to develop strong writers. Students will also benefit from updated science units that align with the Next Generation Science Standards, recently adopted by the Illinois State Board of Education. The new science standards will bring more hands-on labs and inquiry-based learning using scenarios or questions to explore topics.

District 89 has accomplished these initiatives while still balancing the budget with limited increases in revenues. While the district maintains a conservative approach to spending, resources are being stretched. Possible state funding changes or a property tax freeze would move the district into deficit spending. More details are provided on page 3 and online.

# **PEP Grants:** Innovative Learning Opportunities Created With Foundation Funding

The Partnership for Educational Progress has awarded six 2015-2016 grants to District 89 teachers to provide enhanced learning opportunities for students in all five district schools. The grants will provide funding for:

- "Every Drop Counts" Measuring Daily Precipitation as a 6th Grade Class by Glen Crest Middle School teacher Katherine Picicco
- "We Can Wind for Trying," a turbine project at all four elementary schools by Park View teacher Kerin Motsinger, Briar Glen teacher Derek Desjard in, Westfield teacher Sue Pumo and Arbor View teacher Mary Lou Andacht.

## **Music Grant Connects Students With Professionals**

A Young People's Music Initiative Grant will help Glen Crest Middle School band and orchestra students master their instruments with training from professional musicians.

The \$10,000 grant from the JCS Fund of the DuPage Foundation will be distributed in\$2,000 installments over the next five years to fund Master Classes.

Led by professionals in their field of expertise, Master Classes help students learn technique specific to their chosen instruments.

"We have seen students become more experimental in their playing performance," said Kristi Ditsch, instrumental music director. "The Master Class sessions have helped keep students interested in orchestra and our retention rate is increasing from year to year."

The new grant is an extension of a program started two years ago. The JCS Fund has provided \$50,000 in grants over the past two years, which have funded iPads and ukuleles purchases for elementary schools as well as Master Classes.

"All students in District 89 have benefitted from an enriched music program thanks to the support of the JCS Fund," said Assistant Superintendent Dr. Emily Tammaru.

## District Finances: 2015-16 Budget Continues On Conservative Path

The District 89 2015-16 tentative budget continues on a path of conservative spending while achieving strategic planning goals. The \$30 million tentative budget shows a 1 percent surplus while adding full day kindergarten, extending the school day for elementary grades by 30 minutes and technology purchases.


Proposed changes in state funding and a proposed two-year property tax freeze, however, threaten the district's financial stability. On the current expense and revenue trend, the District's fund balance is projected at 12 percent at the end of 2015-16 and falling.

The 2015-16 tentative budget shows expenditures of 55 percent

for salaries, 13 percent for benefits, 10 percent for purchased services, such as transportation and food service, 14 percent to other expenses including tuition for students placed outside the district for special needs, and 3 percent in smaller line items.

Local property taxes provide 91 percent of total revenues while state funding provides 7 percent, and federal funds cover 2 percent.

The District has kept on a steady spending plan for the last ten years. The

district last approved an education fund tax rate increase nearly 30 years ago.

"We've managed (our budget) very carefully and saved everything we could," said Board President Mike Nelson. "If we get hit with property tax freeze or something else, it will hit us quickly."

The Board will hold a public hearing and a vote on the final budget Sept. 21.

### Michael's Place Gets A New Home

There is a special place in Park View School where children can cultivate a lifelong love of reading. It offers a quiet place where grown-ups read them stories or help them improve their fluency.

This special place is known as Michael's Place, created in 2001 by the Pihos family in memory of their son. Michael's parents, former state Rep. Sandy Pihos and her husband, Bill, are champions of public education and literacy. They felt a literacy center benefitting children in the community was a fitting tribute to their son. Michael attended Park View and graduated from Glenbard South before he was killed in an accident in 1999 at the age of 19.

A mural created for the space has been restored and reinstalled in the central hallway for all children to enjoy. A photo collage and article describing Michael Pihos and his achievements hang above a bookcase containing a special collection of books.

Along with the reading space, Michael's Place is the home of a volunteer reading program to help students improve their reading skills.

Principal Barb Petersen hopes the new visibility helps recruit more volunteers to participate in the program.

#### Nelson Takes Seat As Board President

After a 10-year tenure on the Board of Education, Board President Frank Zak resigned from his seat effective Aug. 1, citing personal and professional reasons.

"This was a hard decision for me. Serving on the Board of Education has been my passion for the past ten years," Zak said. "Looking back at our accomplishments, I am happy with the legacy I am leaving and I know the district is in good hands."

Vice President Mike Nelson assumed the post of President per board policy upon Mr. Zak's resignation. Board Member Beth Powers was elected Vice President and Board Member Dr. Sandi-Tapia was elected Secretary Pro Tem. The board is interviewing candidates and is expected to appoint a member to fill Mr. Zak's seat in September.

The appointee will serve until the term for the seat expires in April 2017. Mr. Zak led the board and the district through many accomplishments during his tenure, including a successful bond referendum to modernize schools, recovering from a fire at Briar Glen School and hiring a new superintendent.

Mr. Nelson is currently the longest serving member of the board, serving since 2004.
